6. The customer shall be entitled to enjoy the promotional price for a duration of 1 year from the activation date and for any renewal after 1 year, the customer will be charged the original price of RM69.90/RM49.90 based on the selected package accordingly.

8. TMIM has the rights to halt the customer from continuing to enjoy the promotion if the customer fails to comply with the monthly Instaweb package subscription payment.
